

FRAUD, OUTCROSS, HYBRIDS.....

Wolf hybrids

From our own investigation and statements made by various kennel employees at 'La Briquetterie Vaux Les Rubigny', it is clear that two male studs in the Dutch National Studbook (NHSB) have a phenotype identifying them as wolf hybrids, showing certain characteristics which should not occur in the Saarloos Wolfdog (SWD). A wolf hybrid and its descendants – known from the literature – pose an unacceptable social risk.

Mrs C.A. Keizer (de Louba Tar kennel), who was recently sentenced to 4 months conditional prison time for fraud and animal abuse, owned two wolf hybrids - officially registered as full-blood Saarloos Wolfdogs - which roamed the grounds of la Briquetterie and were used as studs for her "Saarloos" wolfdog kennel.

Wolf hybrid Skog Av Seppalaska NKK N1086902 & LOF 247/039

From witness reports we know that Mrs. Keizer exported and personally delivered one of her SWD bitches to Norway and this female was crossbred to an American wolf hybrid. The puppies however were registered as Saarloos Wolfdogs with a different SWD male as the father.

Even though the breeder is registered as "unknown", Skog Av Seppalaska was bred by O. Nord of 'Av Seppalaska' in Norway out of Venise Poukain Daoine Sidhe (mother) x Skrim Av Seppalaska (father - Yoi Inu Kennel). This Skrim was also owned by O. Nord.

But, this person also owns an American Timberwolf (hybrid) with the same name SKRIM. This animal is the actual genetic father of the litter (and of Skog).

Marijke Saarloos (Van de Kilstroom kennel) and her partner Gerard de Moor tried to socialize Skog somewhat, by using T-Touch training in Giekerk (NL) for 6 months. Being a high-content wolfhybrid, he was completely unapproachable and could not be handled on a leash. Gerard and Marijke were fully aware of the dog's background and after many attempts, Gerard was the only person who could get near him. (Statement by P. W.)

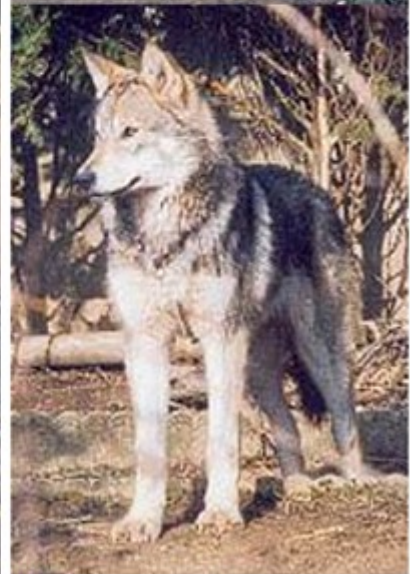
Afterwards, Skog could call the 'de Louba Tar' kennel complex in France his home. On paper his ownership was transferred from Norway to a friend of C.A. Keizer at the De Daim-Pré kennel (LOF) and not Keizer herself. Next to witness statements, we also have unmistakable photo footage - including a picture of the mother with her hybrid son as a puppy on the kennel grounds - and e-mail correspondence between O. Nord and others about his wolfhybrid Skrim that include pictures. Note that this hybrid has the same name as the SWD male that is named as the father. On paper this hybrid male is the result of a mother x son pairing.

Marijke Saarloos who was fully in the know, acquires a Skog descendant together with S. Stoetzer as co-owner. Remarkably, the already mentioned O. Nord was the 'judge' at a (then still dissident) AVLS club meeting in september 2007, where C.A. Keizer and S. Stoetzer were present.

"Yes, this is true. I received Ningbo's pedigree last week and he is called Ehwez. I immediately e-mailed our breeder and she told me that she has multiple kennel names. You can only register a limited number of puppies under your kennel name. On the purchase contract (in French) there is only the dog's name Eyota Ningbo and no mention of any definitive kennel name. All this time I assumed it would be de Louba Tar.

Une femme de 70 ans condamnée à 4 mois de prison avec sursis pour avoir élevé et vendu des chiens sans autorisation

Cornélia, 70 ans, comparaissait ce lundi pour abus de confiance, importation, élevage et revente de chiens non déclarés, et mauvais traitements sur animaux.

En avril 2017, le parquet a été destinataire d'un courrier anonyme expliquant que la prévenue élèverait des chiots de race chien-loup dans des conditions d'hygiène déplorables, au lieu-dit La Briqueterie, à Vaux-les-Rubigny. Ce courrier explique aussi qu'elle vend ses chiots sous le couvert d'une association : Les Loups Ravis, association visant à l'accueil des chiens de race primitive en situation d'abandon. Les services d'enquête ont constaté, en se rendant sur les lieux, la présence de 83 chiens adultes d'une maigreur inquiétante et vivant dans des boîtes vétustes.

Sous le régime de la garde à vue, la prévenue a expliqué qu'aux Pays Bas, son pays d'origine, un particulier peut détenir des chiens sans autorisation, et leur faire faire 4 portées par an, équivalent à 20 naissances annuelles et qu'elle n'a donc pas pensé à demander une autorisation particulière. Elle reconnaît devant le tribunal tous les chefs de prévention sauf celui de maltraitance et celui d'abus de confiance, précisant que les animaux étaient nourris et soignés avec son argent personnel, c'est la raison pour laquelle elle encaissait les chèques sur son compte personnel plutôt que sur celui de l'association.

Un nouveau rapport datant du 12 octobre dernier montre qu'aujourd'hui, Cornélia n'est plus en infraction puisqu'elle n'a plus que 8 chiens, ce qui correspond à la réglementation en vigueur, les autres ayant été récupérés par les services de la SPA. Elle est relaxée pour le fait d'abus de confiance et est condamnée pour l'ensemble des autres chefs de prévention à 4 mois de prison avec sursis.

A 70-year old woman has been sentenced to 4 months conditional prison time for unauthorised breeding and selling of dogs

Cornelia, 70 years old, was led to trial for abuse of trust, the import, breeding and reselling of undeclared dogs and animal abuse.

In April 2017, the public prosecutor's office received an anonymous letter explaining that the defendant was raising wolfdog puppies in appalling hygienic conditions at a place called La Briqueterie, in Vaux-les-Ruibigny. The letter also explained that she was selling puppies under the cover of an organisation: 'Les Loups Ravis'. This charity organisation shelters abandoned primitive dog breeds. The investigation team discovered 83 adult dogs of such a disturbing thinness living in deteriorating dog cages on the premises.

The defendant explained to the authorities that in the Netherlands – her country of origin – a private person can keep dogs without a permit and can breed up to 4 litters a year, or the equivalent of 20 annual births. She therefore did not think of applying for specific breeding permits. She pleaded guilty to all charges before the court, except the one of animal abuse and abuse of trust, stating that the animals were fed and cared for with her own money, which is why she was cashing checks into her own bank account instead of the organisation's account.

A new report dated 12th October shows that Cornelia is no longer in violation as she has no more than 8 dogs, which corresponds to the current legislation in place. The other dogs have been collected by the local animal rescue organisation (SPA). She was cleared of the trust abuse charges and sentenced to 4 months conditional prison time for all the other charges as a whole.
